#### **POSITION OVERVIEW**

Develops policies and procedures for ensuring the security and integrity of the company's network systems and data, and assists the implementation of security measures.

## PERFORMANCE-BASED JOB FUNCTIONS AND OBJECTIVES

- 1. Support the integrity of the Ho-Chunk Nation's information measures.
- 2. Coordinate counter measures and monitor effectiveness for the prevention of system intrusion on a daily basis.
- 3. Maintain and provide solutions for prevention of security failures as needed.
- 4. Respond to the findings of IT Audits with solutions, recommendations and corrections as findings are received.
- 5. Participate in the designing, planning and coordination of projects as projects arise.
- 6. Maintain a disaster recovery and business continuation plans for information systems on a quarterly basis
- 7. Complete research of security tools, or upgrades; provides recommendations to the IT Director by the end of the second FY quarter.
- 8. Provide training and guidance for HCN personnel in the prevention, detection and correction of security solutions for the Nation's networks as topics arise.
- 9. Continue to enhance personal skills and education to meet the growing needs of the Nation annually as the budget allows.
- 10. Provide report to supervisor on a quarterly basis.
- 11. Perform other duties as assigned as relevant to job description.
